Appendix:

Statement of Special Character

The Integration Deed of Agreement with the Ministry of Education says that the school must always be run so as to maintain the Special Character according to the Special Character Statement below.

1. Hastings Christian School is a year 1-13 composite school established by the Hawke's Bay Christian School Association (The Proprietor) to provide a Christian education in keeping with the Constitution of the Proprietor for parents who desire such an education as an extension of that given in their own homes.
2. The Special Character of the school is determined by the Christian beliefs and values held by the Proprietor as stated in the following historic Reformed Confessions – the Heidelberg Catechism, the Belgic Confession, and the Canons of Dort; or the Westminster Confession of Faith; or the Thirty-nine Articles of Faith of the Church of England – and summarised in the Statement of Beliefs. The Proprietor reserves the right to interpret the Special Character and to determine from time to time what is necessary to preserve and safeguard it.
3. All members of the school community, Proprietor, trustees, parents, staff and pupils are expected to uphold the Special Character in the life and activities of the school.
4. All learning programmes, including those based on the New Zealand Curriculum framework, shall be taught from a Biblical perspective in accord with the Special Character of the School, subject to sections 31 and 32 of the Act.
5. The school aims to teach pupils the knowledge of God as He reveals Himself in the Scriptures of the Old and New Testaments, the knowledge of His creative, providential and redemptive works, and a knowledge of human societies, cultures, literature, science and technology from a Biblical perspective. The goal of this instruction is to equip the pupils with the basic skills needed to function effectively as Christians and citizens in today's world and to equip them for the vocation God gives them. So that the pupils may fulfill their vocation the school seeks to:
 - Inculcate an awareness that all of life is to be lived before God.
 - Enable them to discern what is good in human history, culture, science and technology.
 - Strengthen their commitment to Christ and His church.
 - Help them develop their talents so they may serve God and their neighbours more effectively.
 - Train them to live in obedience to God's Word in every aspect of life.

Attendance Dues

Fees of \$1,100 per year are payable to Hawke's Bay Christian School Association spread over the year with a payment due at the beginning of each term. Automatic payments can be arranged with the treasurer.

Voluntary Donations

The Hawke's Bay Christian School Association (the Proprietor) is requesting voluntary donations to assist with the development of buildings and property. Enrolment Scheme

Maximum Roll

The Ministry of Education has required the Board of Trustees (BOT) to put in place an enrolment scheme for entry into Hastings Christian School. The BOT is required to work within the maximum roll under the Integration Agreement.

Enrolment Priority

The Hastings Christian School, as a State integrated school, has been given greater flexibility by the MOE to enable the school to ensure that the maintenance of the school's Special Character remains the prime focus of its enrolment policy.

A preference of enrolment at the school under Section 29 (1) of the Act shall be given to students whose parents or guardians have established a particular or general connection with the Special Character of Hastings Christian School. Preference will be determined by the Proprietor (Hawke's Bay Christian School Association).

The Board shall not give preference of enrolment to the parents or guardians of any student unless the Proprietor concurs that those parents have established a particular or general connection with the Special Character of the school.

Application for enrolment will proceed in the following order of priority to ensure enrolment of those students whose parents or guardians are most closely aligned with the Special Character of the school.

First Priority

Preference students whose parents/caregivers are members of the Hawke's Bay Christian School Association. Students will be accepted based on the following order of sub-priority:

1. Living in the area of reasonable convenience*

- Siblings of current or former students
- Children of full time teachers at school
- Others

2. Living out of the area of reasonable convenience in the same sub-priority as above.

- The area of reasonable convenience is defined as the Hastings territorial local authority including the Napier territorial local authority.
- Priority of entry for the above will be based on the date of application.

Second Priority

Other preference students will be accepted using the same order of sub-priority as that specified for students in the "First Priority".

Third Priority

If all preferential applicants can be enrolled, the school is able to enrol a number of non-preference students, limited to 5% of the maximum roll of the school. Non preference students will be selected based on the date of application.

Pre-enrolment

Each year applications for enrolment will be sought by a specified date, which will be published in a daily or community newspaper circulating in the area served by the school.

If the total number of applicants is greater than the number of places available, unsuccessful applicants go on the waiting list according to the above priorities.

Students on the waiting list may be offered places at a later date if places become available.

Informing Parents/Caregivers

Within 30 days of the closing date for applications, parents/caregivers will be informed of their child's place on the waiting list. If places become available at a later date, places will be offered to children according to our enrolment procedure.
